



Dear New and Returning Vendors:

As we prepare for the 2017-2018 academic year, the Office of Student Life and Development invites you to participate in the upcoming Vendors Day exhibit dates. **MERCHANDISE VENDORS PLEASE NOTE THAT THE LOCATION FOR VENDORS DAY IS THE LIVING LEARNING CENTER DINING HALL PERIMETER.**

Merchandise vendors interested in vending during Fall 2017 / Spring 2018 academic year may do so for **\$75.00** per day, and during special events (i.e., Spring Fling and Homecoming) you may do so for **\$200.00** per day. Food vendors must pay **\$500.00/\$650.00** (depending on date of arrival) to vend at **special events**. Lastly, the Annual Membership Rate is now **\$900.00** (excluding dates for special events).

**** Unfortunately, tables are not provided, but each vendor is allowed to bring up to two (2) tables. ****

Food Vendors: Food vendors are required to pay a \$300.00 NON REFUNDABLE deposit in addition to the cost of the special events vending fee. The deposit must be received within TEN (10) business days prior to your arrival or you will not be allowed on campus or to vend – NO EXCEPTIONS.

Vendors are not allowed to park in the vending area, cars are only permitted to load/unload in the space. Public safety will ticket and or tow your vehicle if you fail to follow parking regulations on campus.

Lincoln University has a **ZERO TOLERANCE** alcohol, drug and harassment policy. If in the event where any of these policies are violated, Public Safety will be notified and escort you off of the premises. Refunds will not be processed under these circumstances – **NO EXCEPTIONS.**

Attached you will find a copy of the Vendor Application. For **EACH** Vendors Day exhibit date, please remit payment two (2) weeks prior to the day of vending. - Tables will not be provided. Each vendor is allowed to bring up to two (2) tables.

- Vendor locations are assigned on a first-come, first-served basis.
